


Risk and Return

THA Participant-Directed Retirement Plan – Investment Objectives

The Investment Committee will review performance of the Participant-Directed Retirement Plan investment managers with respect to the stated objectives and generally in the context of a three- to five-year time horizon.

Core Investment Options

Tier I

Target Date Funds

Approximate the annualized total return of each fund's custom index.

Tier II

Balanced Index Fund

Approximate the annualized total return of 60% CRSP U.S. Total Market Index/40% Bloomberg Barclays U.S. Aggregate Float Adjusted Index.

Intermediate Core Bond Index Fund

Approximate the annualized total return of the Bloomberg Barclays Aggregate Float-Adjusted Index.

Large Cap Equity Index Fund

Approximate the annualized total return of the S&P 500 Index.

Mid Cap Equity Index Fund

Approximate the annualized total return of the CRSP U.S. Mid Cap Index.

Small Cap Equity Index Fund

Approximate the annualized total return of the CRSP U.S. Small Cap Index.

International Equity Index Fund

Approximate the annualized total return of the FTSE Global All Cap ex U.S. Index.

International Emerging Markets Equity Index Fund

Approximate the annualized total return of the MSCI Emerging Markets Index.

Tier III

Stable Value Fund

Exceed the annualized total return of the 90-Day U.S. Treasury Bill.

Intermediate Core Bond Fund

Exceed the annualized total return of the Bloomberg Barclays Aggregate Index.

THA Participant-Directed Retirement Plan - Funds/Managers

Tier I

• BlackRock LifePath Index Funds – Each of these funds represents an asset allocation portfolio (i.e., diversified among broad asset classes) that is targeted to a specific retirement date. As the retirement date approaches, the allocation across the asset classes becomes more conservative. Each of the LifePath Index Funds is invested in multiple underlying funds to achieve broad asset exposure.

Tier II

- Vanguard Balanced Index Fund This fund seeks to track the performance of the 60% CRSP U.S. Total Market Index/40% Bloomberg Barclays U.S. Aggregate Float Adjusted Index
- Vanguard Total Bond Market Index Fund This fund invests in investment-grade corporate, U.S. Treasury, mortgage-backed, and asset-backed securities. Its passive investment style uses optimized sampling to closely match the benchmark's characteristics in sector weight, coupon, maturity, effective duration, convexity, and credit quality. It is an intermediate-duration portfolio which provides moderate current income with high credit quality.
- Vanguard Institutional Index Fund This fund seeks to track the performance of the S&P 500 Index.
- Vanguard Mid Cap Index Fund This fund seeks to track the performance of the CRSP U.S. Mid Cap Index.
- Vanguard Small Cap Index Fund This fund seeks to track the performance of the CRSP U.S. Small Cap Index.
- Vanguard Total International Stock Index Fund This fund invests substantially all of its assets in the common stocks included in the FTSE Global All Cap ex U.S. Index based on each region's weighting in the index.
- Vanguard Emerging Markets Stock Index Fund This fund seeks to track the performance of the FTSE Emerging Markets All Cap China A Inclusion Index.

Tier III

- Prudential Guaranteed Income Fund This fund is a group annuity contract issued by the Prudential Retirement and Annuity Company and is backed by the creditworthiness of the issuer's general account. Prudential declares an annual interest rate which is subject to change on July 1 and December 31 of each year.
- Schwab Government Money Market Fund The fund actively invests in U.S. government securities and other obligations issued or guaranteed by the U.S. government to generate income while maintaining liquidity.
- Invesco Stable Value Trust The strategy uses a "building block" approach in portfolio construction, investing in externally and internally managed sub-advised collective funds to promote diversification and to capitalize on complementary investment styles.
- PIMCO Total Return Fund This fund invests primarily in a broad range of bonds including government bonds, corporate bonds, mortgage-backed bonds, foreign bonds, and short-term instruments. It invests primarily in investment grade debt securities but may invest a portion of assets in high yield securities. The goal of this fund is to seek a total return that exceeds short-term rates, but the fund will experience price variability in the underlying portfolio holdings.

THA Participant-Directed Retirement Plan – Funds/Managers

- PIMCO Real Return Fund This fund invests primarily in inflation-indexed bonds of varying maturities issued by U.S. and non-U.S. governments, their agencies, and corporations. The goal of this fund is to provide a long-term total return that will exceed inflation. The return may reflect more variability- especially over shorter measurement periods than money market or stable value funds.
- Transamerica Mid Cap Value Opportunities Fund TS&W's investment process uses a quantitative, front-end screen and independent, fundamental research to identify and invest in stocks that are trading at a discount on a cash-flow valuation basis and where positive change that can close that discount is in evidence. The firm uses the same investment process to manage all long-only equity portfolios with the objective of delivering consistent excess returns versus each strategy's stated benchmark.
- **DFA U.S. Small Cap Equity Fund**The strategy is guided by an investment philosophy based on rigorous academic and empirical research, the U.S. Small Cap Equity strategy is a disciplined solution designed to cost-effectively target premiums along the dimensions of expected returns. The strategy invests in U.S. small cap stocks and offers broad diversification across sectors and securities.
- Dodge & Cox International Stock Fund This fund applies a value-oriented philosophy to invest in a well-diversified portfolio of international stocks primarily listed
 across developed country markets. The primary focus is on mid and large cap stocks, and the portfolio will generally include allocations to emerging market stocks.
