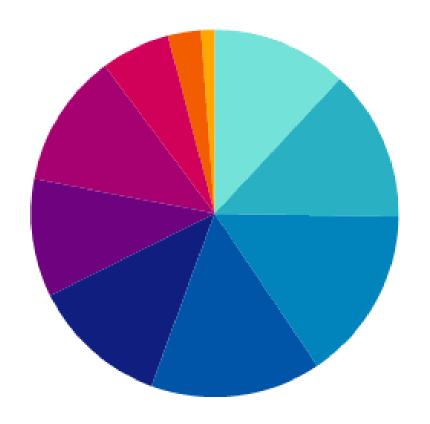


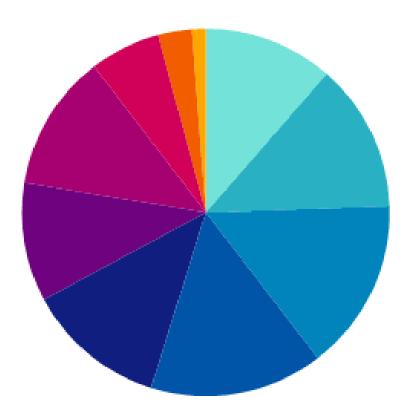
Asset Allocation by Target Date Fund Vintage
